# President Tolson's Remarks

## Sheriff Kevin Tolson, President South Carolina Sheriffs' Association

Sometimes, you do not fully appreciate the significance of a moment until you are in the middle of it. Then, it hits you and you realize how special it is. This is truly special, and I am humbled by the opportunity to serve as your President.

I cannot let Sheriff Crenshaw's time as President conclude without saying a few things about him. I have a couple of constructive criticisms for Sheriff Crenshaw. ## **Progressive Leadership and an Inclusive Approach** SCSA's 2021 Sheriff of the Year, Sheriff Leon Lott of Richland County

Sheriff Leon Lott is a 43-year career law enforcement officer who leads one of the largest Sheriff's departments in the southeastern United States. Under his leadership, the nearly 1,000-employee Richland County Sheriff's Department (RCSD) has been recognized as one of the most creative, innovative, bridge-building law enforcement agencies in the nation.

During his 23 years in office, Sheriff Lott's extraordinary vision and creativity have enhanced the public trust of citizens. Since taking office in 1997, he has launched innovative programs designed to uplift, support, and protect

all communities in his jurisdiction. *Community-Oriented Policing* was introduced as a holistic approach to address degenerative community conditions and reduce fear of victimization. *Project H.O.P.E.* was initiated to support seniors lacking needed assistance from family and friends through

volunteers who call and visit hundreds of disabled citizens each month. *The Community Action Team* was formed to further build bridges between citizens and law enforcement so that both groups had a sense of ownership in their communities. These initiatives and several more like them have furthered RCSD's efforts to restore dignity, fairness, compassion, and trust of law enforcement.

In 2018, Sheriff Lott was the first sheriff to launch the

PEACE OFFICER identity program, a new framework for community policing, in collaboration with the nonprofit organization Police2Peace. This first-of-its-kind innovation has enhanced public trust, police legitimacy, deputy safety, and the willingness of the public to assist in the RCSD's crime-fighting efforts.

Recently being named Sheriff of the Year by the National Sheriff's Association, it is our privilege to recognize Sheriff Lott as SCSA's 2021 Sheriff of the Year for the State of South Carolina. Congratulations and thank you, Sheriff Lott. Your efforts have reflected positively on the entire South Carolina law enforcement community.

## **Above and Beyond** SCSA's 2021 Deputy of the Year, Senior Corporal Gary Beaver of Sumter County

Sr. Cpl. Gary Beaver began his career with the Sumter County Sheriff's Office in 1994 as a Reserve Deputy while serving as a member of the United States Air Force.

In 1996, he was hired as a Class 1 Officer and assigned to the Civil Process Division. He has been an exemplary member of this division ever since, committed to serving the citizens of Sumter County in this capacity. Sr. Cpl. Beaver has served in excess of 57,000 civil documents.

Sr. Cpl. Beaver understands his role is first and foremost that of a Deputy Sheriff. He is always quick to respond to need, and Sumter County Sheriff Anthony Dennis says fellow officers are relieved to know he is '10-8' to any situation.

This was never more evident than on February 25, 2020, when he and two fellow officers were met with gunfire as they arrived to serve papers. While the suspect's actions resulted in the death of Cpl. Andrew Gillette, Sr. Cpl. Beaver relied on his training and experience, returning fire and ending the threat. For his valiant efforts that day, Sr. Cpl. Beaver was awarded the Medal of Valor.

Sr. Cpl. Beaver models the values of a consummate law enforcement professional on a dailv basis. He is respectful to everyone he comes into contact with and treats all citizens with dignity and compassion. At a time when law enforcement agencies face the public perception of 'bad cops,' Sr. Cpl. Beaver stands

## **Life Saving Ingenuity and Action** SCSA's 2021 Detention Officer of the Year, Chesterfield County's Sheila Gillespie-Buckman

S CSA is proud to recognize the Director of the Chesterfield County Detention Center, Sheila Gillespie-Buckman, as our 2021 Detention Officer of the Year. Her submission was based upon her response to the COVID 19 pandemic, implementing safety procedures from the onset, which undoubtedly saved lives.

Sheila was instrumental in obtaining supplies such as sanitizer and masks from many different sources with whom she has contacts, in spite of how difficult it was to locate and procure these supplies early on. She was able to keep not only our jail, but also our sheriff's office supplied with these necessary items until the market was able to catch up with demand.

In addition to securing these critical supplies, Sheila was able to quickly implement procedures to isolate and quarantine incoming inmates until they could be medically cleared to go into population. She organized COVID testing and implemented limited inmate movement directives in our facility before DHEC even produced guidelines to address these matters.

As a result of Sheila's ingenuity and actions, our

detention center remained COVID free for several months. When we did eventually see our first cases of the virus, Sheila put together protocols for safely caring for infected inmates, containing the outbreak to one pod.

While every detention facility faced these same challenges, Chesterfield County, located in a more rural area, did so with very little guidance or assistance from state and federal agencies. Director Gillespie-Buckman's efforts undoubtedly saved lives.
