# President Ravenell's Remarks

#### Sheriff Leroy Ravenell, President South Carolina Sheriffs' Association

Sheriff Leroy Ravenell of Orangeburg County was sworn in as the 2022-2023 President of the South Carolina Sheriffs' Association at the Association's Annual Conference. Sheriff Ravenell delivered a powerful speech that challenged and inspired all. Here is a portion of Sheriff Ravenell's comments.

"I am honored and humbled to be standing in front of you today as the South Carolina Sheriffs' Association President. I am privileged to stand with my fellow Sheriffs and continue to represent all 46 Sheriffs with 1 Voice. We must continue to be the standard in our communities and within our profession. This standard does not mean that you are perfect; it does, however, mean that daily you strive to serve with integrity, dignity, and respect of the office in which we have taken our Oath.

We are blessed every day to serve the men and women of our agencies and those that live and work within our counties. Simply put, Luke 12: 48 instructs us that, 'to whom much is given, much is required.'

The requirements do not come without sacrifice. We must be careful that the sacrifice does not cost you, YOU! Don't forget the YOU behind the badge. The YOU that drew you to this profession, The YOU that fueled your passion to serve your community, The YOU that causes you to be seen as a hero in the eyes of others but a servant at heart. The YOU that has a family who cares about you and prays for you every day and night. The YOU that needs to realize that your shoulders are not designed to carry the weight of the World. Yes, we are considered superheroes in many regards, but we must know when and how to take the capes off.

This year we will remain focused on the agenda of LEGISLATION, concentrating on topics such as deleting the earnings limitation on working retirees, continuing to fight "medical" marijuana, and income tax deduction on all income for first

I leave you with what has carried me for 30+ years of service - serve with humility, keep God first and always remain firm, fair, and consistent. May God keep us ALL."



#### **Not About Ego or Accolades but What's Best for His Community** SCSA's 2022 Sheriff of the Year, Sheriff D. Max Dorsey II of Chester County

Sheriff Max Dorsey was nominated for Sheriff of the Year by several of his peers, each recognizing the humility and selflessness he brings in serving each resident of Chester County. Recognized by all as a man who doesn't bring a personal agenda to his work, it's never about ego or accolades with Sheriff Dorsey but what's best for his community. He is keenly aware of the public's scrutiny of law enforcement, and he welcomes that scrutiny, accepting it as a challenge to change the script, to demonstrate that law enforcement is here to serve the public and protect all of those who live in the community. Under Sheriff Dorsey's leadership, Chester County is becoming an example of one of the best and most respected law enforcement agencies in S.C.

Sheriff Dorsey and his office have built connections in the community, encouraging stakeholders to become involved in improving law enforcement's response in the county. He's implemented several community events, Coffee with Cops, fundraisers, and social media channels to deepen community ties and improve communication. He's created and implemented an open-door policy for all citizens to voice their concerns, share ideas, and become vested in the progress of the Sheriffs' Office.

While operating with one of the smallest budgets among his peers, Sheriff Dorsey has been somewhat of a miracle worker managing to upgrade his office's capabilities and resources, all while coming in under budget two years running. He's secured more than \$2 million in grant money, portions of which went

towards adding six new deputy positions, and through other fundraising means, he added another SRO at Lewisville Middle School.

# **Exemplary Investigative Teamwork in Closing Cold Cases** SCSA's 2022 Deputy of the Year, Master Deputy Jason Cox and Master Deputy Jonathan Howard of Greenville County

"Although this award is typically given to a single deputy for exemplary performance during the course of the last year, I would like to nominate both Investigator Jason Cox and Investigator Jonathan Howard for SCSA Deputy of the Year. I could not nominate one of them without the other."

Investigator Jason Cox and Investigator Jonathan Howard are currently assigned to the Cold Case Homicide Unit of the Greenville County Sheriff's Office within the Criminal Investigations Division. Both have been in this position over the past year and their partnership and teamwork have been exemplary during this period. They have developed an outstanding working relationship and have worked together in unison to bring several cold cases to closure.

Investigating more than 90 active cold case homicides, some of which date back to the 1960s, Investigators Cox and Howard have put their training, experience, and hard work ethic to use in finding answers. They have picked up cases where they were left by other investigators and hit the ground running, reviewing the case file, reviewing evidence, re-interviewing witnesses, searching for any new additional evidence and witnesses, adding to the work of the original investigators to develop enough evidence to make arrests. In the past year, they have cleared five cold case homicides. These cases date as far back as 2001. -Sgt. Mike Jarvis, Greenville County Sheriff's Office

Investigators Cox and Howard have each served 13 years in law enforcement. Their stellar efforts this past year in building upon the efforts of earlier investigators and closing cold cases is not only exemplary police work, but also demonstrates perseverance and determination to bring justice for cold case victims and closure for their loved ones, many of whom have expressed their sincere appreciation to Investigators Cox and Howard.

### **Life Saving Awareness & Action** SCSA's 2022 Detention Officer of the Year, PFC Philip Vaughn of Berkeley County

"I am pleased to nominate PFC Philip Vaughn for SCSA's 2022 Detention Officer of the Year. Mr. Vaughn has worked in the Hill Finklea Detention Center in Berkeley County for just over a year. In that time, he has distinguished himself by his exemplary performance of his duties."

In just over a year that PFC Vaughn has been with the HFDC, he's proven to be an asset in the supervision of our inmates, having written or been involved in some twentynine incidents. PFC Vaughn has observed the passing of and intercepted contraband. Observing an inmate's strange behavior on a video monitor, Officer Vaughn moved to interrupt a suicide attempt, saving an inmate's life and getting him the help he needed. On still another occasion, Officer Vaughn was feeding inmates in an overcrowded housing unit when he was jumped by a mentally challenged inmate. He was able to fight the inmate off to the extent he was able to broadcast a garbled call for assistance. With the help of another inmate, Officer Vaughn was able to handcuff and hold the assailant at bay until help arrived. Although physically injured in the altercation, Officer Vaughn returned to work still bruised.

Officer Vaughn has clearly established himself as a valuable member of the team in Berkeley County, and he's demonstrated courage, valor, and professionalism in his work at the Hill Finklea Detention Center. We recognize PFC Vaughn for the exemplary performance of his duties, and we invite you to join us in thanking and congratulating him.
